
### **Nailsea Christmas Lights**




#### On the Beat

The AGM of our local 'Partners And Communities Together' group was held on 6th January. Previously on 19th of November there had been a town Community Safety meeting at which Nailsea residents said they still wanted a team. However, due to lack of attendance at the AGM and the lack of commitment to become involved, it was decided that the PACT group should be dissolved.

Over many years, the PACT group (formerly LAT) had reduced the menace of pavement parking substantially, their view being that our pavements should be for pedestrians. There have been many other initiatives working with both the Police and Town Council. Community Speedwatch will continue to operate as an independent unit as it has grown from strength to strength. The PACT Chairman, John Hunter, would like to thank everyone who has contributed to both LAT and PACT over the years.

## A few home security tips Bogus Callers and Rogue Traders

'Not sure? Don't open the door!' Most callers are genuine, but watch out for alleged utility workers, council workers, police or repair workers who haven't made an appointment. If you're alone and unsure, ask them to come back later when someone else will be there

#### Lock up

Deadlock doors and close and close windows if you go out or upstairs. Unlocked UPVC units can be sprung. Keep keys away from doors and windows in a place where they are not visible to anyone looking in, and don't hide them outside.

Get a strong door with insurance company-approved locks. Fit an entry viewer and/or a good door chain or door bar. A letterbox cage will prevent lock release or theft via the letterbox. Change locks in new houses so only you have keys. Don't give keys to anyone you do not know well.


The Master Locksmiths Association (MLA) licenses its approved locksmiths through a process of vetting and checking. Visit the MLA website to search for an MLA-approved and registered locksmith

#### While you're away

Don't make it obvious that your home is empty. Use timer switches for lights (preferably upstairs), radios (tuned to talk stations), and a 'fake TV' flickering light box. Ask a neighbour to keep a car parked in the driveway. Ask someone to take in mail, milk, dustbins etc. If you have a trusted neighbour, friend or relative with a key, ask them to close the curtains at night and open them in the morning

#### **CYBER CRIME**

Cyber crime encompasses any criminal activity using computers and networks. It includes online fraud, identity theft and the abuse of young people. More criminals are exploiting the speed, convenience and anonymity of the internet where they can maximise profit quickly. Avon and Somerset Police recently announced that cyber crime is on the increase.

There have been many instances of online fraud in the news. People being coerced into parting with their money on the basis of an email telling them they had won a competition or were overdue with a parking fine. The amount of money in each case may be small, but online criminals targeting thousands of victims can make a lot of money quickly. If you receive such an email, ask yourself - have I ever entered this competition or was my vehicle parked there? Always treat such emails with suspicion. If in doubt – delete it. Another example is an email, allegedly from your Bank or Credit Card Company, informing you that you are overdrawn or your account has been frozen due to suspicious activity.

These are phishing emails and they often contain a link for you to open. If you receive such an email and believe it is a scam, you should NEVER reply to the email or open any link within it. You should report it by contacting the organisation using a valid email address/telephone number – not one from the email. Then delete the email. All the Banks have an email address and telephone number you can use to report scam emails:
