Nailsea Christmas Lights




USEFUL PHONE NUMBERS

Nailsea police secure the first conviction within Avon & Somerset police for "Disclosing Private Sexual Images with Intent to Cause Distress".

A 29-year-old man from Bristol has become the first person in the Avon and Somerset area to be sentenced for under new revenge porn laws. The man, from Shirehampton, admitted the charge and a second



charge of harassment, at North Somerset Magistrates' Court in Worle and was

given a six-month suspended prison sentence. The male had printed off private sexual photographs of his victim and left them in a public place in Nailsea.

Following the sentencing hearing, Somerset Area Superintendent Mike Prior said: "Disclosing private sexual images – or so-called 'revenge porn' – is a new offence under the Criminal Justice and Courts Act 2015 and this is the first time we've successfully used these new powers." **Secondly** on Friday 15th January Nailsea police and North Somerset Council were involved in a day of action, targeting inconsiderate drivers, dog fouling, cycling within the precinct and general reassurance patrols. Officer's identified 16 parking offences outside the local schools and words of advice will be given accordingly to the drivers. The council also assisted with the patrols offering advice on council issues. The day went well with a stronger partnership built between the police and council, giving the opportunity for more events to be planned in the future.

Nuisance Communications

If a person sends threatening/offensive/abusive messages to you, whether it is online, on the phone, or even by post, they could be committing an offence. Important: If you are receiving threatening communications which you believe are real and immediate, you should call 999 straight away.

Malicious calls

A malicious communication is the offence of sending someone a letter or electronic communication (including phone call) which is offensive, which contains a threat or damaging information which is known to be false. In the first instance, and where you are not in immediate danger, it is advised to contact your mobile network provider who has specialist teams in place to deal with such situations.

Report it

To report an on-going issue with malicious calls fill in the Report a crime or incident form* or call 101.

Nuisance calls

Nuisance calls tend to be as a result of marketing companies using automatic diallers. Often, instead of a person on the other end of the line you hear an information message from the organisation that is trying to call you. Most nuisance calls are caused by the use of automated dialler technology to maximise the amount of time call centre agents spend speaking to consumers. This technology may not always work as intended. For example, if the dialler makes a call but there is no call centre agent on hand to deal with it, you might receive an abandoned or silent call or a pre-recorded message.

Report it

At the very least these calls can be annoying and disruptive, but they can also be unnerving and frightening for some people. As a result, there are strict rules which these companies must stick to.

If you are receiving high volumes of nuisance, abandoned or silent calls you should report them to Ofcom on 0300 123 3333.

Threats or Abuse Online

Malicious communications can also be received online: Email, Social Media i.e. Facebook and Twitter, Internet forums and Online gaming. It is important to take the correct steps if you receive malicious communications online. Keep a diary and record the times and dates you receive a malicious communication.

Report it

The provider of the online service in question should be the first point of contact before the police, as they also have procedures in place to manage and deal with such incidents.

If you feel the communication puts you in immediate danger, please dial 999 straightaway.

To report an on-going issue with online abuse call 101 .


